State Health Society, Punjab implementing National Health Mission in the State of Punjab requires CUG Mobile Phone Connections/ Dongles with internet Connections for better coordination and communication among different categories of employees working at State Head Quarter NHM Punjab, Chandigarh and 23 districts in the State of Punjab for smooth implementation of Health related activities. State Health Society, Punjab hereby invites sealed bids from the Mobile Phone Service Providers in the State of Punjab for the supply of following services: -

- ii. The bidder shall be operating in the State of Punjab having 100 % network coverage and the service provider/bidder must have connectivity/operation in all the areas of the State of Punjab.
- iii. The bidder shall be able to integrate with USSD gateway of NIC.

v. The average annual turnover of the bidder in the previous 3 years i.e. FY 2019-2020 to FY 2021-2022 should not be less than Rs. 50 Crore per year and turn over certificate in original as per Annexure-I duly attested by Chartered Accountant must be attached with bid.

vi. Bids of bidders quoting as authorized representative of the original Mobile Service Providers can be considered, provided the bidder furnishes a legally enforceable authorization from the Original Mobile Service Provider in the prescribed form (**Annexure-II**).

vii. State Health Society Punjab will not pay any cost towards SIM charges, security deposit (Local/STD) and installation/activation charges. SIM cards are to be issued in the name of SHS.

viii. The bidder should have never been blacklisted/debarred/de-registered by any Government /Government undertaking. The bidder should submit a Notarized Undertaking/affidavit certifying that their firm has never been blacklisted/debarred/de-registered by any Government department/ Government undertaking in the sample format provided at **Annexure-VI**.

ix. a) Bidder submitting the bid for category I must submit Demand Draft of Rs. Rs. 10,00,000/- (Rs. Ten lakh Only) as Earnest Money Deposit in shape of Demand Draft in favor of **State Health Society, Punjab** payable at Chandigarh.

b) Bidder submitting the bid for category II must submit Demand Draft of Rs. 50,000/- (Rs. Fifty Thousand Only) as Earnest Money Deposit in shape of Demand Draft in favor of **State Health Society, Punjab** payable at Chandigarh.

x. The Demand draft of EMD must accompany the technical tender, without which the tender will not be considered. The said amount will be forfeited, if any successful bidder fails to execute the contract or fails to furnish

the performance security within the stipulated time period or withdraw/rescind from offer/bid.

- xi. Delivery and activation time will be of maximum 15 days from the date of award of tender.
- xii. The bidder must provide a full time Service Manager at State level and one person at each District level who:
  - a) Should be responsible for all the relevant issues like billing issues, payments, issuing of new SIM cards in case previous SIM card is damaged or lost, mobile number /SIM card swapping, suspension or restoration, network or signal related issues.
  - b) Must be available during standard business hours (9.00 am to 6.00 pm) via email/telephone/SMS. There must be a specified individual to serve as backup during vacations and other times if the nominated Service manager is not available. The alternate manager must be able to be reached for emergency purposes during off hours.
- xiii. No promotional or marketing SMS/call should be received on CUG number. DND service should be activated forever on all CUG numbers.
- xiv. The Vendor shall issue new connection on the request of SHS Punjab within 2 days. This includes delivery of SIMs and activation of the SIMs within the stipulated period.
- xv. No VAS (Value Added Services) i.e. (Hello tunes, Game shows) facility be provided on any of the CUG connection until the request is forwarded by SHS Punjab. In case, any VAS is activated on CUG SIM without prior permission from SHS, no payment will be made.
- xvi. Receipt of Tender fees (annexure X) must be enclosed with the Technical bid, without which tender will be summarily rejected without any consideration. In case the tender is downloaded from the official website of NHM Punjab, tender fees should be enclosed in the form of Demand Draft/Account payee Cheque in favour of "State Health Society" Punjab.
- xvii. The quantity of mobile connections/Dongle with Internet Connection mentioned in the schedule of requirement are tentative quantities and can be increased / decreased by 20%.
- xviii. Bidder shall provide temporary barring of numbers, which are not in use. Temporary Barring means service provider would not charge any rent on the SIMs which are not being used. Temporary barring should be provided for at least 1 year.
- xix. Service Provider submitting the bid for Dongle with Internet Connection is required to provide the Dongle free of Cost and the same will remain the property of NHM Punjab after the expiry of contract.
- xx. Free Outgoing calls within the circle include all the mobile calls within CUG Group and Free Outgoing calls outside circle includes mobile calls to any mobile number outside CUG Connection, to land line phone and nationally (means users shall be able to call Nationally from anywhere within India). National Roaming is also required on all the numbers as mentioned above. No roaming charges to be levied.
- xxi. The successful bidder shall be responsible for providing mobile number portability on all the existing numbers and facilities to get the existing number spotted. The successful bidder will ensure good signal strengths and uninterrupted communication. If required, service provider shall install booster/antenna or other device at his own cost within a week after getting the complaint.
- xxii. Bidder is required to submit copies of Last three months GST 3B return i.e. June 2022 to August 2022 and Two Years Income Tax Returns i.e. AY 2020-21 to 2021-22.
- xxiii. Bidder is required to submit the details of other institutional orders executed by the bidder during last three financial years i.e. 2019 to 2022 as per Annexure III.
- xxiv. The successful bidder will provide the software/dashboard with respect to numbers issued to each employee/user for activation/de-activation of numbers and information of data usage of each user of CUG, raising of complaints by the user and their redressal.
- xxv. The SHS through its employees shall have the right to access the software at any time to check/verify any detail monitor complaint redressal and de-activate number of any user. The data is in the software shall belong to SHS Punjab only and shall not be used by the service provider.
- xxvi. The successful bidder shall undertake to provide 5G or higher services (Voice + Data) on the same rate, terms and conditions as and when launched in the State of Punjab.
- xxvii. All the new connections shall be provided in a single series.



**Section-IV**  
**Other Terms and Conditions**

- 1.0 Sealed Bids in two separate covers (Technical bid and Price bid) in original will be received till 28.10.2022 by 02:00 PM in the office of Mission Director, NHM, Punjab, Chandigarh marked as **“Bid for the Mobile Connections and Bid for Dongle with 4G/5G Internet Connections”**.
- 2.0 The bid, all correspondence and documents shall be in English Language.
- 3.0 Interested eligible bidders may obtain further information from Mr. Sorabh, Accounts Officer, O/o Mission Director, Prayaas Building, Sector 38, Chandigarh.
- 4.0 Bidding documents may either be obtained from the above O/o Mission Director, State Health Society, National Health Mission, Prayaas Building, Sector 38, Chandigarh between 9.00 a.m. to 5.00 p.m. on all working days either in person on payment of tender fees mentioned in clause 2 of **General instructions** or same may be downloaded from tender section of official website <https://nhm.punjab.gov.in> of NHM Punjab.
- 5.0 Bidder should read all the terms and conditions of the bid document properly before submitting the tender.
- 6.0 Bids will be opened in the presence of bidders/their representatives who prefer to attend on the specified date and time.
- 7.0 Rates should be quoted at F.O.R destination which will be at O/o Mission Director-NHM, Pb, 5<sup>th</sup> Floor, Sector 38-B, Chandigarh for Mobile Connection SIMs and Dongle with Internet Connections pertaining to State Health Society, Punjab and O/o Civil Surgeon of respective district for Mobile Connection SIMs and Dongle with Internet Connections pertaining to Districts. The successful bidder shall ensure delivery and activation of SIMs within 15 days of issue of Award. SHS Punjab will not reimburse any expenditure incurred by bidder for delivery of Mobile Phone SIMs and Dongle with Internet Connections at State Head Quarter NHM Punjab and O/o Civil Surgeons of respective districts.
- If the supplier fails to execute the purchase order within the stipulated time, the NHM, Punjab, Chandigarh is empowered to make emergency purchases and claim the difference in total cost from the supplier in addition to other penal remedies.
- The deliveries shall be made strictly as per the purchase order
- 8.0 Bids should be as per tender document invited by the department. Bids in any other format will not be considered.
- 9.0 Tender received after the time and date specified for receipt of tenders will not be entertained.
- 10.0 Contract once concluded shall be valid for 24 months from date of issuance of Award and can be further extended on prevailing terms and conditions up to one year or till new tender is finalized whichever is earlier.
- 11.0 At any time prior to the date of submission of bid, NHM may, for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the bidding document by an amendment. All prospective bidders who have received the bidding document will be notified of the amendment in writing/online up-dation and that will be binding on them. In order to allow reasonable time, for taking the amendment into account, NHM may at its discretion, extend the date and time for submission of bids.
- 12.0 In case of Loss of SIM card and Non-functioning of the SIM card, Service Provider will be responsible for providing new SIM card free of cost to the user. Service provider will provide a local contact in each district for attending the local issues.
- 13.0 If any of the dongle gets faulty within the contract period, tenderer has to arrange for repair/ replacement of the data card within 24 hours from the time of complaint, otherwise no payment will be made for that card for the full month. The tenderer is bound to provide the stand-by arrangements, if the complaint is expected to be sorted out beyond 24 hours and SHS Punjab will not be bound to pay any charges for such stand-by arrangements.
- 14.0 Price bid shall be valid for 90 days from the date of opening of the Technical bids. A bid valid for a

shorter period will be rejected as non-responsive. NHM will make every endeavor to finalize the bids in the original validity period of the bids. However, if for any reason, NHM is not able to finalize the tender within the original validity period of the bids, NHM may solicit the bidders consent for an extension in the period of bid validity. A bidder may refuse the request without forfeiting their bid security.

15.0 Each bid must be accompanied with a bid security (EMD) in the form of Demand Draft favoring State Health Society-Punjab, payable at Chandigarh for the amount indicated against each item in schedule of requirements. **Bid Security submitted in any other form will not be accepted.** Any bid submitted without Bid Security in accordance with this clause will be rejected. The Bid Security amount of the successful bidder will be retained by NHM till the completion of the tender process/period. The Bid Security of unsuccessful bidder would be returned after finalization of the tender. The Bid Security amount will not carry any interest. If the successful bidder fails to execute the agreement and or deposit the Performance Security (Security Deposit) within the specified time, or withdraws his bid within the validity period of the bid, this bid security amount will be forfeited. No exemption is available to any organization from submission of bid security and bids not accompanied by the requisite bid security will be rejected out rightly.

16.0 No bid conditions like “AT CURRENT MARKET RATES” shall be accepted. No handling, clearing, transport charges etc., will be paid. The deliveries should be made as stipulated in the purchase order placed with successful bidders.

17.0 Incomplete or conditional offer incorporating price maintained and force majeure etc. will not be entertained.

18.0 If at any time during the period of contract, the price of tendered items is reduced or brought down by any law or Act of the Central or State Government or by the bidder himself, the bidder shall be morally and statutorily bound to inform and offer the said rates to the Mission Director, NHM, Punjab, Chandigarh immediately. **The Mission Director, NHM, Punjab, Chandigarh is empowered to unilaterally effect such reduction as is necessary in rates, in case the bidder fails to notify or fails to agree for such reduction of rates, from the date such reduction has been otherwise implemented.**

19.0 The rates quoted in the bid will be binding on the bidder for the stipulated period and no request for increase in the price will be entertained till the completion of the tender period.

No bidder will be allowed at any time on any ground whatsoever to claim revision of or modification in the rates quoted by him. The representation of the bidder that clerical error, Typographical error etc. has been committed in the bid and request for revision shall not be considered after opening of the bid. Conditions such as “SUBJECT TO AVAILABILITY” “SUPPLIES WILL BE MADE AS AND WHEN SUPPLIES ARE RECEIVED” etc., will not be considered under any circumstances and the bids of those who have placed such conditions shall be treated as conditional and such bids, shall be summarily rejected.

20.0 The monthly bill should not exceed the number of active connections and should strictly be as per the approved plan and rates finalized in the tender. SHS Punjab will not make any payment of charges which are not as per approved plans and rates.

21.0 The Successful bidder shall be responsible for updating existing applications, if required centrally, without any further extra cost.

22.0 If any new application as mandated by MoH&FW of GoI/ Punjab Government is to be uploaded on all the numbers, then the Service Provider will be paid at a mutually agreed rate.

1. The bidder should furnish, along with bid, the following for the items tendered in a separate cover hereafter called “Cover A”.
  - (a) Duly signed and stamped copy in original of Tender Document.
  - (b) The Demand Draft/Account payee Cheque or copy of receipts (issued by O/o MD NHM) in regard to receipt of tender fees for providing tender document to bidder should be attached with the Technical Bid.
  - (c) Bid Security (Earnest Money Deposit) should be deposited in the form of Bank/Demand Draft drawn in favor of State Health Society, Punjab payable at Chandigarh.
  - (d) Duly self-attested photocopy of License issued by the Department of Telecommunication, GoI of India for providing GSM/Volte/LTE Mobile Phone and Internet Services in State of Punjab.
  - (e) Documentary evidence for the constitution of the bidding organization e.g. companies firms etc. such as Memorandum and Articles of Association, Partnership deed etc. with details of the Name, Address, Telephone Number, Fax No., Email address of the firm and of the Managing Director/Partners/ Proprietor exclusively.
  - (f) Authorization like power of attorney, resolution of board, for the senior officer of the company who has signed the tender documents and the bid. In case of partnership firm authority like Power of Attorney for the partner who has signed the bid and in case of sole proprietorship the bid should be signed by the sole proprietor.
  - (g) Annual Turnover Certificate for last 3 financial years i.e. FY 2019-20 to FY 2021-2022 in the format given in **Annexure-I** certified by Chartered Accountant.

### Section-VI

#### Procedure for Evaluation of bids

- 1) **Technical Bid Cover “A”:** On the basis of the documents submitted by the bidder in cover “A” the committee will check whether the bidder fulfills the eligibility criteria and whether the offer of the bidder meets the requirement of the tender.
- 2) **Price Bid Cover “B”:** The price bid of the bidders fulfilling the technical eligibility criteria eligibility will be evaluated as under:

If the successful bidder fails to execute the award and /or deposit the required Performance Security within the specified time or withdraws his tender after the intimation of the acceptance of his tender, sent to him or owing to any other reasons, he is unable to undertake the contract, his contract will be cancelled and the Earnest Money Deposited by him along with his tender shall stand forfeited to the NHM-Pb., Chandigarh.
