Subject :- Inward Movement of people- Provision in COVA app for those staying less than 72 hours in Punjab

Please refer to this office letter No. SCCR/2020/320, dated 11.07.2020. Relevant process flow to be followed by teams stationed at CPs has been attached with this letter for information & compliance.

In reference to Letter No. SCCR/2020/320 dated 11/07/2020 following changes have been made in COVA App:

1. Individuals who come to the State of Punjab by pre-registering themselves using e-Registration option on COVA Mobile App or web link: <http://cova.punjab.gov.in/registration> have been provided with an option to declare whether they will stay in Punjab for "Upto 72 hours" or "More than 72 hours". This consent is taken from user as per following:

- a. In case applicant chooses "Upto 72 hours" as the option, consent is taken as per format mentioned Annexure 1 of Letter No. SCCR/2020/320 dated 11/07/2020
- b. In case applicant chooses "More than 72 hours" as the option, consent is taken as per format mentioned below:

"I hereby declare that all the members whose details are entered in the form, are true and correct to the best of my knowledge and belief. I/We hereby undertake that it is mandatory for me/us to self-home quarantine for a period of 14 days as we are going to stay more than 72 hours in State of Punjab. I/We declare to download the Cova App and undertake to daily update health status either on the Cova app or 112 number."

- c. This information is saved in COVA Platform and can be checked by concerned officers by logging into COVA Portal
2. For the individuals who come to the State of Punjab without pre-registering themselves via COVA App or web link, the designated nodal officers at Border Check Post will register incoming travelers by visiting the "Traveller Registration" page on employee section of COVA Mobile App.
 - a. A new option has been added on the "Traveller Registration" page to mention if incoming travellers will stay in Punjab for:
 - i. "Upto 72 hours"
 - ii. "More than 72 hours".

- b. The nodal officer on Border Check Post has to verify the point mentioned in 2.a from traveller and fill in the App.
- c. The nodal officer on Border Check Post has to inform the traveller about this guideline.
- d. Following SMS will be sent to traveler on basis of option selection in 2.a.i or 2.a.ii respectively
 - i. Dear User, you have just been registered as inward traveler to state of Punjab. You have given information not to stay for more than 72 Hrs in the State of Punjab from your arrival in Punjab. In case you have not given this input, please call 112 within 3 hours of receiving this SMS.
 - ii. Dear User, you have just been registered as inward traveler to state of Punjab. You have given information that you will stay for more than 72 hours in the State of Punjab. You undertake to self-home quarantine for a period of 14 days. In case you have not given this input, please call 112 within 3 hours of receiving this SMS.
- e. This information is saved in COVA Platform and can be checked by concerned officers by logging into COVA Portal
