Subject COVID-19: Notification of facilities / hospitals as Isolation Hospital in the State of Punjab



1. These facilities will become operational as and when the occupancy in the earlier notified facilities exceed 50% of the total availability of beds.
2. In the facilities which have been set up away from existing hospitals like the Urban Community Health Centres, Rehabilitation Centres and private hospitals which have been taken over by the Government, any SMO or Programme Officer now posted in the district will be given additional charge by the Civil Surgeon.
3. The Civil Surgeons and concerned SMO will ensure setting up of proper sample drawing facility at all these facilities as per protocol.
4. The Civil Surgeons and SMO concerned will ensure manning of the isolation facilities as per protocol.
5. Adequate availability of PPE kits, N-95 masks, Triple layer masks at the sample drawing facilities and the isolation facilities will be ensured by the Civil Surgeons through NHM.
6. Civil Surgeon of the district will ensure providing manpower, Medical Officers (Medical Specialists), Medical Officers (ENT), General Duty Medical Officers, Nurses, Technicians and other staff as per requirement, from within the district. Rural Medical Officers and Community Health Officers can be utilized for this purpose.
7. Proper management of the sampling facilities and the isolation facilities is the responsibility of the concerned Civil Surgeon.
8. In case of clarification the concerned Civil Surgeon or any other official responsible may get in touch with Director Health Services.


9. Name and contact number of incharge of these isolation facilities to be mailed immediately at pshfw@punjab.gov.in directorhealth-pb@punjab.gov.in and outbreakcellpunjab@gmail.com
10. Guidelines for setting up isolation facilities / wards as issued by Ministry of Health and Family Welfare, New Delhi, Govt. of India are enclosed with this order. These guidelines should be implemented in letter and spirit.
11. It is again reiterated that the ingress and egress of these facilities should be separate for COVID-19 where there are other services being provided in the same facility which has been notified as COVID-19 facilities it will be the responsibility of the Civil Surgeon and concerned SMO to ensure securing of these facilities from COVID-19 ward. Funds already sent to Civil Surgeon can be utilized for this purpose where ever required.
