Sub: Additional restrictions in cities of Jalandhar, Ludhiana and Patiala during Unlock 3.

1. This is in continuation to this office letter No. SS/SCSH/2020/560 dated the 31st July 2020 (copy attached) vide which guidelines for Unlock 3.0 to be implemented from 01.08.2020 to 31.08.2020 were circu ated for compliance.

2. Subsequently, vide letter No.SS/SCSH/2020/569 dated the 4th August 2020 (copy attached), yoga institutes and gymnasiums viere also allowed to beopened from 5th August 2020 subject to their compliance with guidelines of MoHFW, Gol.

3. On account of sudden rise in COVID-19 cases in urban areas of the State particularly in Jalandhar, Ludhiana and Patiala, it is necessary to impose additional restrictions and curtail timings of certain activities in these 3 cities. Accordingly, additional restrictions are imposed as under within municipal limits of these 3 cities w.e.f. 08th August 2020 **till further orders:**

1. Night curfew (9.00 pm to 5.00 am):

Movement of individuals for all the non-essential activities shall remain prohibited between 9.00 pm to 5.00 am within municipal limits of these 3 cities.

However, essential activities including operation of multiple shifts, movement of persons and goods on National and State Highways and unloading of cargo and travel of persons to their destinations after disembarking from buses, trains and aeroplanes will be permitted.

Similarly, all industries running into 2-3 shifts will also remain open.
