- Whereas Government of Punjab has imposed penalties in case of violation of Government instructions and guidelines regarding prevention & control of COVID-19 vide letter No. IDSP/NHM/PB/20/5848 Dated 29/05/2020.
- Whereas for better management and control of COVID-19, it is felt that these penalties need to be enhanced and made more stringent. I, Dr. Avneet Kaur, Director Health Services Punjab, impose the following penalties under regulations framed under Epidemic Disease Act 1897:-
  - I. For violating the home quarantine instructions: Rs. 200/
  - II. For not wearing a mask in public places: Rs. 500/
  - III. For spitting at public place: Rs. 500/-
  - IV. For violating social distancing norms by owners of Shops/Commercial places: Rs.2000/-.
  - V. For violating the social distancing norms by vehicle owners will be fined as follows:
    - (a) Auto-rickshaws/Two-wheelers: Rs. 500/-
    - (b) Cars: Rs. 2000/-
    - (c) Buses: Rs. 3000/-
  - VI. For violating social distancing norms by owners of Restaurants /Commercial eating places the owners will be fined: Rs. 5000/-
  - VII. For violating the protocol for home isolations by COVID-19 patients: Rs. 5000/-
  - VIII. For violating social distancing in case of social gathering of more than norms: Rs. 10,000/-
- All officials not below the post of B.D.P.O, Naib Tehsildar, A.S.I. and any other official authorized by Deputy Commissioner can impose the aforementioned penalties under the provisions of Epidemic Disease Act, 1897.

4. Non-payment of fine by the violator will attract proceeding under section 188 of IPC as per the regulations framed under the Epidemic Disease Act, 1897.
