1	Age	Up to 45 years, Age criteria may be relaxed in case of non availability of a suitable candidate.
2	Knowledge of Punjabi	Candidates should have passed subject of Punjabi upto Matric standard. If the candidate has not passed Punjabi upto Matric, he will be given 6 months time to pass the subject.
3	Venue of Interview	O/o Mission Director, NHM Punjab, 5 th Floor, Prayas Building, Sector 38 B Chandigarh

1. Candidate must fulfill eligibility criteria for the post he/she is applying for as on date of Walk in Interview of respective post. The applicant must read carefully all the guidelines and instructions mentioned on the website before appearing for walk in interview.
2. Candidates must ensure to bring their original testimonials related to Qualification, Experience, Punjabi upto Matriculation, Age proof etc. and one self attested photocopy of all such documents for submission.
3. Candidates must bring 2 latest passport size photographs at the time of interview.
4. In case, any certificate/testimonial of an applicant is found fake at any stage of recruitment or issued by an incompetent authority, the eligibility/appointment of that applicant would be cancelled with immediate effect and a legal action may be taken against him/her. If any candidate is found not to be fulfilling the eligibility/selection criteria at the time of interview or at any point of time in the entire recruitment process by the screening or selection committee, his/her candidature will be cancelled/rejected for the said post.
5. Appearing for Walk in Interview does not imply that candidate has fulfilled all the criteria given in the advertisement and he/she is eligible for the post. Eligibility of the candidate will be determined after thorough scrutiny of the application filled by the candidate. If candidate is found not eligible by the screening committee, he will not be allowed to appear in the interview before the selection committee.

6. Candidates will not be paid any TA/DA for attending the above said interview/test.
